Dear Mr. Hynes,

Greetings, and Happy New Year. I'm the associate of the US Senate-connected terrorism researcher Lois Ann Battuello. We met at the interfaith/anti-racism event in Bay Ridge, this fall.

I need your help. I have stumbled on a story that advances the public understanding of who the 9/11 attackers were, who helped them, and how it is they were able to pull off the unlikely attacks.

I have published an article in *The New York Megaphone* (a copy is enclosed, as Exhibit A. I also enclose our previous issue, which provides an overview of a shift towards public skepticism around the official explanation of the attacks.)

My latest story builds on the work of Florida researcher Daniel Hopsicker, who discovered that 9/11 ringleader Mohamed Atta had connections to certain shady Europeans and Americans. His Florida drinking buddy Wolfgang Bohringer is a German-born, naturalized US citizen who this past year admitted to several witnesses in the South Pacific that he was friends with Atta. In November, Bohringer caught the attention of the Joint Terrorism Task Force and the government of the tiny island nation of Kiribati, when he submitted plans to open a flight school on a remote island in the South Pacific. (See Exhibit B, published by Homeland Security.)

As you can see in my article, the JTTF declared Bohringer a "person of interest" in a November 16, 2006 "terror alert." I have reason to believe that Bohringer was apprehended, on the 17th of November, that Friday. Lois Ann Battuello herself happened to be visiting Brooklyn that weekend, and on November 18th, overheard a speaker-phone conversation while being driven to my coffeehouse, Vox Pop, by former NYPD hostage negotiator Wally Zeines. She was very excited when she arrived, because, she said that an arrest had been made. She said that the caller, from JTTF, was also very excited. She had heard him say: "The first thing out of his mouth made him go from a '5' to an '8'" (on a scale of importance). Allegedly, Bohringer had claimed to the JTTF agents, "You can't arrest me, I'm working for the CIA."

Lois had implied that the arrestee was Wolfgang Bohringer, and never expressed any doubt about this, over the weekend. Lois and I thought that this was a major coup, since JTTF had been using her research, and the research of our mutual friend, Dan Hopsicker. In fact, I took six pages of notes from Lois's discussion of the meaning of this arrest, and how Bohringer's "CIA" is actually more likely ex-CIA rogue networks connected to

the Iran/Contra and BCCI criminal milieus.

Yet two days after the conversation, she began to back-pedal about this. She claimed it was not Bohringer, after all. She attempted to prevent me reporting this story. I am not sure why. Lois has been a great help to 9/11 and government corruption researchers. But she may be getting pressure from someone to go the other way now, on this story. Yet, she herself on December 7, wrote me an email and said, about Wolfgang Bohringer. “Maybe the CIA disappeared him, but I had nothing to do with that if that is the case.”

I went and got what corroboration I could of the Bohringer arrest. My secondary source was Randy Glass, who is the subject for Chapters 1 and 11 in my book, *The Big Wedding: 9/11, the Whistle-Blowers, and the Cover-Up* (Exhibit C.) A streetwise former con man, he did heroic work as an undercover informant, posing as an arms dealer and stinging Pakistani terrorists for the JTTF in Operation Diamondback, in the years leading up to 9/11. Former Senator Bob Graham confirmed on camera that Glass knew about the World Trade Center 9/11 attacks in advance, and had in fact *warned* Graham. Glass has since risked his own neck to try to let the American people know that nothing is as it seems with the 9/11 attacks.

Today, Glass is retired, living in Florida, selling real estate. Yet he remains connected to CIA and NSA sources. I asked him to use his contacts to confirm Bohringer’s November 17 arrest for me. A week later, Glass called me back and left me a short message, “The answer is yes, and he’s working—can’t talk about it.”

Bohringer’s probable release follows several precedents for well-connected informants, operatives or patsies being apprehended by police, and then being released at the bequest of more Federally-connected law enforcement. For just one example, recall FBI/CIA informant Ali Mohamed. He was the “top spy” of Osama bin Laden, according to Peter Lance’s new book *Triple Cross*. Mohamed was arrested in Toronto in 1993, but a single phone call to FBI got him released. (See page 48 of my book for more on this.) Precedents helped me recognize what is probably going on here with a cover-up around Bohringer, the 9/11 attackers, and all the American agents of destruction who aided and abetted them.

Take a look at the enclosed materials. I know this JTTF operation is a Federal investigation, but frankly, that’s a big part of the problem. As we saw with the BCCI scandal, the DOJ and FBI were not willing to do a thorough investigation of the international criminals (and Bush family members) involved in BCCI. It was only the Manhattan DA’s office who launched an investigation that got any results.

There is sufficient evidence for the Brooklyn DA’s office to open a case against the 9/11 conspirators. There is enough public skepticism about the official story to compel public officials to start thinking outside the box.

You have jurisdiction. As recent news reports tell us (Exhibit D) Mohamed Atta traveled throughout Brooklyn, especially to the El Farouq Mosque. (El Farouq has been linked to Blind Sheikh Abdel Rahman, another US-government-connected leading figure in the terrorist underworld.) This news about Atta in Brooklyn came out in the 2006 Congressional hearings into the Pentagon’s Able Danger operation. The Pentagon investigated itself regarding this under-reported affair. The DOD issued a report that absolved itself of any wrongdoing. But that’s inexplicable.

On February 15, 2006, Lt. Col. Anthony Shaffer gave a 48-page statement to the House Armed Services Committee, in which he stated, unequivocally, that his Defense Intelligence operation, Able Danger, identified Mohamed Atta as a major terrorist back in year 2000. Shaffer and his team of top military operators were

prevented from sharing this information with the FBI, by their superiors. According to Shaffer, during a crucial meeting the group's Pentagon supervisors and attorneys from the Special Operations Command in early 2000, the Able Danger team was ordered to cover Atta's mugshot with a yellow sticky note. Military lawyers at the Pentagon claimed it was to protect the rights of "U.S. Persons." Atta was an Egyptian citizen holding several passports, and multiple forms of identification. It appears that someone deep inside the Pentagon was affording him a level of civil rights protection denied to many U.S. citizens these days!

It's been five years since 9/11, but gnawing questions about the attacks still need to be addressed. 9/11 widow Monica Gabrielle was also here at Vox Pop, at the book event on November 18. According to her fellow "Jersey Girls" Mindy Kleinberg and Lorie Van Auken, leading members of the Family Steering Committee, the 9/11 Commission failed to answer a whopping 70% of their questions about the attacks.

I know you've seen a lot in your long and arduous career, but the crime of 9/11 may be the biggest one that we have to confront—together.

I hereby volunteer to help your office assemble a blue-ribbon Citizens Advisory Panel of experts, law enforcement personnel, former intelligence professionals, writers and researchers who could contribute some solid independent guidance on the issue of 9/11.

That panel would likely include myself and:

Janice Matthews (co-facilitator, [911truth.org](http://911truth.org))

Peter Lance (the five-time Emmy award winning journalist)

Eric Larsen (author and former professor from John Jay),

Bob Baer (former CIA)

Robert Steele (former CIA, founder of Open Source Intelligence, [OSS.net](http://OSS.net))

Daniel Hopsicker (author of *Welcome to Terrorland* probably the best book on Atta)

Kyle Hence (Director, 9/11 Citizens Watch)

John Judge (Staff Member to Rep. Cynthia McKinney, co-director of Washington Peace Center)

Lucy Komissar (whose new research on BCCI links the bank to the far-right Muslim Brotherhood)

The list could go on. The panel could be a way to have your office benefit from cooperative research methods, and the collective work made possible by new technology. 9/11 is a national scar, but healing and truth are still possible. Please contact me to discuss this proposal.
